Determination of Offer Price and allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Friday, 27 November 2020 and, in any event, not later than Monday, 30 November 2020. Applicants are required to pay, on application, the maximum Offer Price of HK\$0.27 for each Public Offer Share together with brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%. If the Offer Price is not agreed between the Company and the Joint Bookrunners (for themselves and on behalf of the Underwriters) on or before Monday, 30 November 2020, the Share Offer will not proceed and will lapse immediately. Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
